Annual Percentage Rate (APR) for Purchases	11.00%, 11.50%, 13.50%, 16.50%, 21.50%, or 22.50% depending on your credit history.  This APR will vary with the market based on the Prime Rate.
APR for Cash Advances	13.00%, 13.50%, 15.50%, 18.50%, 23.50%, or 24.50% depending on your credit history. This APR will vary with the market based on the Prime Rate.

Paying Interest	Your due date will be at least 23 days after the closing date of each billing cycle. We will begin charging interest on cash advances and balance transfers on the date the cash advance or balance transfer is posted to your account.
