evergreenDIRECT Credit Union Audit Committee Annual Report April 17, 2024

The Audit Committee is elected by the membership and is an integral part of evergreenDIRECT Credit Union's (eDCU) corporate governance structure. In this capacity, the Committee provides oversight to ensure the Credit Union's internal policies, procedures, and practices reflect those of a sound, and continuously improving, internal control environment that safeguards Members' assets and ensures adherence to applicable laws and regulations.

To achieve our objectives, the Committee met regularly during 2023 and oversaw various audits as well as the examination performed by our regulators, Washington's Department of Financial Institutions, Division of Credit Unions. The Committee engaged Randall Audit and Consulting to perform this year's agreed upon procedures audit. We are pleased to report there were no exceptions or recommendations noted because of this audit. We reviewed the results of these and other regulatory audits and examinations to ensure that management provided adequate and timely responses when requested. The Committee also received regular updates on the Credit Union's financial performance.

eDCU continues to be professionally managed, financially sound and in compliance with generally accepted accounting principles. The Credit Union remains in excellent condition, having met all regulatory requirements.

Call to Order
