The criteria for this scholarship is based on (in order of importance):

- The applicant's financial need
- Community involvement
- Scholastic standing (GPA or demonstrated potential in his/her chosen field/major)

evergreenDIRECT Credit Union Scholarship Fund 2026

Eligible Students

Each applicant must be a member or eligible for membership at evergreenDIRECT Credit Union; and either planning to enroll or already enrolled as a **full-time student** (minimum 12 term/semester hours) at an eligible institution. Student must have a minimum 2.5 grade point average. **Students without a 2.5 GPA are still encouraged to apply.** Students without recent high school transcripts and/or an eligible grade point average should follow instructions marketing with “*” at the end of the application.

Eligible Institutions

Eligible institutions include any public or private, generally accredited two-year or four-year institutions of post-secondary education, including vocational training and school.

Conditions of Eligibility

- (1) Need for this scholarship shall be defined as a student having insufficient resources to meet the required educational costs at the institution in which the student has been accepted for enrollment. These costs shall include: tuition, fees, books, supplies, and room and board.
- (2) Community involvement is the second-ranked criteria for eligibility.
- (3) A student must demonstrate educational potential. This may be demonstrated by high school, college, or vocational program records or by submission of a letter* and references giving background information which demonstrates educational potential.

Amount of Scholarship

There will be at least **two scholarships** awarded - each in the amount of **\$1,000**.

The award shall be for the period of one (1) academic year.

Members should apply every year. The scholarship *does not* automatically renew.

Application Procedures

Interested evergreenDIRECT Credit Union members may request an application from the credit union or by downloading the forms from evergreenDIRECT.org.

The completed application, financial information, and letters or transcripts must be returned to **evergreenDIRECT Credit Union** no later than **April 15, 2026**. In order to be notified of results *if you are not awarded a scholarship*, please inform the credit union that you are an applicant by emailing Marketing@evergreenDIRECT.org.

Selection

The recipients shall be selected by evergreenDIRECT Credit Union. For selection, applicants shall be ranked according to:

- 1) Financial need (as determined by analysis presented in student's application).
- 2) Community involvement.
- 3) Level of academic achievement (as determined by grade point average or demonstrated potential in a specific field or major)

Scholarships will be awarded to the two applicants with the highest ranking in the following order:

- 1) Qualified applicants who are not prior recipients of the scholarship
- 2) Qualified renewal applicants who are prior recipients of the scholarship.

Award Notification

evergreenDIRECT Credit Union will send the recipients a notice of the award specifying the terms of the award. **The recipients shall be required to sign and return one copy of the award notice** to the credit union acknowledging the terms and certifying the scholarship funds will be used for educational expenses.

Disbursements

A check in the name of the recipient will be sent in one lump sum from the credit union to the financial aid office of the institution to be attended. The financial aid office will disburse funds in payment of fees or charges (books, supplies, etc.) upon verification of registration as a full-time student (minimum 12 term/semester hours).

Note: If the student's start date is delayed for any reason, please notify the credit union as soon as possible for the scholarship to be deferred.

Refunds

Refunds resulting from the student's failure to complete a full study period will be returned to evergreenDIRECT Credit Union.
